

## PROCLAMATION DECLARING STATE OF EMERGENCY

WHEREAS, the World Health Organization (WHO) has declared COVID-19 (Coronavirus) to be a global pandemic; and

WHEREAS, the President of the United States has declared an infectious disease national emergency declaration to combat COVID-19; and

WHEREAS, the Governor of the State of Oklahoma has declared an emergency by the impending threat of COVID-19 for all 77 Oklahoma Counties; and

WHEREAS, health professionals and researchers have determined that COVID-19 is spread by human interaction and interaction; and

WHEREAS, avoidance of human contact through methods such as social distancing is believed to stop the spread of COVID-19; and

WHEREAS, the spread of COVID-19 is a disaster affecting life, health and safety of Yukon residents and non-residents alike; and

WHEREAS, the provisions of Section 74-98 of the Yukon Code of Ordinances along with State Law permit the Mayor of the City of Yukon to proclaim that a state of emergency exists within any area of the City:

NOW, THEREFORE, BY VIRTUE OF THE AUTHORITY VESTED IN ME BY THE STATE OF OKLAHOMA, I, MICHAEL MCEACHERN, MAYOR OF THE CITY OF YUKON, DO HEREBY PROCLAIM AND DECLARE:

<u>SECTION ONE:</u> A state of emergency exists within the corporate limits of the City of Yukon, Canadian County, Oklahoma.

<u>SECTION TWO:</u> This proclamation shall become effective 12:01 AM March 17, 2020.

<u>SECTION THREE:</u> The following City of Yukon Facilities shall be closed and all programming and events at said locations shall be postponed and or canceled until the expiration of this emergency declaration:

Dale Robertson Senior Center
Yukon Public Library
Jackie Cooper Gymnasium
Yukon Community Center
Yukon Parks and Recreation (leagues, facilities, and events)

The following City of Yukon facilities will remain open for individual access, however all public and private gatherings, meetings, and events are hereby postponed and canceled and no permits for gatherings, meetings, and events at said locations shall be issued until the expiration of this emergency declaration:

## All City of Yukon Parks

<u>SECTION FOUR:</u> The City Manager shall revoke any pending permit and not issue any new permit for any public or private event on any City street, sidewalk, facility, park, or property until the expiration of this emergency declaration.

SECTION FIVE: Meetings of all City of Yukon authorities, boards, commissions, committees, and trusts are postponed and/or canceled until the expiration of this emergency declaration. All meetings of the Yukon City Council and Yukon Municipal Authority are exempt from this cancellation requirement. These meetings will remain open to the public but steps will be taken to ensure no close contact between attendees. City Council and Municipal Authority meetings will continue to be televised.

<u>SECTION SIX:</u> All Yukon Municipal Court dockets are canceled. Cases scheduled for arraignment, hearing, and trial will be rescheduled. This includes all juvenile dockets. The Municipal Judge shall issue an order rescheduling cases and the Municipal Court Clerk shall issue written notification of new court dates.

<u>SECTION SEVEN:</u> All in-person gatherings for social, spiritual, and recreational purposes, including but not limited to community, civic, public, leisure, faith-based, or sporting events; parades, concerts, festivals, conventions, fundraisers and similar activities are strongly discouraged until the expiration of this emergency declaration.

<u>SECTION EIGHT:</u> Restaurants, bars, and other privately owned gathering places are highly encouraged to limit the number of patrons such that at least six (6) feet of space is available to each patron. Such facilities are further encouraged to transition to "take-out" or "delivery" options.

<u>SECTION NINE</u>: Local gyms and exercise facilities are encouraged to discontinue all group activities and to significantly increase and enhance facility cleaning and disinfecting activity.
